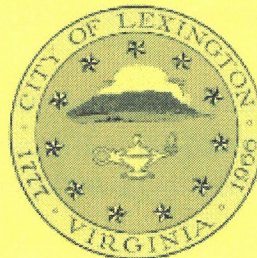
Proposed Constitutional Amendment
