City Manager's Report

City Manager's Meeting regarding Downtown Fire Suppression: Building Inspector, Fire Department, Fire Marshall, VA Fire Marshall, W&L, Historic Lexington Foundation, Main Street Lexington, IDA Start Time: 5:42 p.m. (DropBox Audio: 10:00)

City Manager Carroll explained the need of fire suppression in downtown buildings and the genesis of the fire suppression incentive program. There will be a meeting on September 19, 2024, for stakeholders to discuss this program. Chair Miller further explained the need for fire suppression in the downtown area by giving examples of past fires and the impact from a fire in the downtown area. City Manager Carroll stated that City Council will be considering setting aside \$250,000 for this program at their September 19, 2024, meeting and will be holding a work session to discuss this program on October 8, 2024.

 - o Employment: total employment, unemployment rate, employment by sector
 - o Income: Average compensation, over-capita income, average wage
 - Investment: capital investment per job, commercial investment, private/public investment
 - o Housing: residential vacancy rates, total residential square footage
 - o Percentage of owner-occupied housing
 - Office space: office vacancy rate, total office square footage
 - Arts & Entertainment: Count of theaters, performing arts venues, annual attendance at events, annual visitors for key attractions
 - Number of new businesses opened
 - o Number of full-time jobs created
 - Number of business closures
 - Number of building permits issued
 - Change in unemployment rate
 - Tax revenue
